Service Terms

Intended Service Use

Certus IoT service plans are intended for data use only where applications may include machine-to-machine, tracking, telemetry, condition monitoring and SCADA.

Intended usage excludes:

- Telephony and VOIP functionality
- General maritime and land mobile communications (e.g. email, texting, chat, voice)

Standard Terms

- Pricing is in Australian Dollar EX GST
- M2M One standard Terms and Conditions apply
- Monthly Recurring Charge (MRC) is billed monthly in arrears unless otherwise specified
- Overage charges are billed monthly in arrears at the rate specified in the service plan
- Each subscription has a minimum commitment of 3 or 12 months as specified
- Early termination fees will be automatically charged for any subscription terminated within the minimum commitment term
- Plan pricing is subject to change with thirty (30) days written notice

Certus IoT Terms

Sessions are charged in 100 Byte increments with a minimum 1KB charge per session

*Certus Contract Terms

Supplier rules state that no pro-rata credits are offered upon Certus service deactivation. This rule has to be likewise enforced by Ground Control. Minimum billing term is therefore the stated number of months, plus the initial pro-rata on activation to get to the next invoice date. Please consider activation timings.

Dynamic Shared Groups (DSG)

- Subscribers on eligible service plans within an organisation may aggregate their monthly data allowance into a pool which can be shared across all subscriptions.
- DSG is available only on service plans marked as eligible
- All subscriptions in the group must be subscribed to the same service plan
- DSG is charged monthly at additional 10% of the service plan MRC per subscription
- Each billing cycle any data usage that exceeds the DSG pool allowance (overage) will be billed at the overage rate for the subscription plan plus 10%
- Each DSG requires a minimum of five active subscriptions
- Each DSG has a minimum commitment term of 12 months
- Early termination fees will be automatically charged for any DSG terminated within the minimum commitment term
